Resolutions Approved:

- 1. Approval of Funds Transfer to TANA Foundation INDIA: TANA foundation INDIA registration for the NON Profit status is expiring soon and INDIA team started the process of registration process again. Niranjan explained that the process may take several weeks and without the registration TANA Foundation cannot send funds TO INDIA, so he requested Foundation trustees to approve budget for activities without interruption in INDIA for coming few months of operations, for the same he proposed at least \$200000 funds transferred to TANA foundation INDIA before status expires. Former Foundation treasurer Ramakanth explained to have at least \$250000 and if we do not use the funds, we can bring the funds back to USA. The resolution to transfer funds first proposed by Bhakta Balla and seconded by Viswanath Nayunipeta. Board unanimously approved the proposal by Niranjan to transfer \$250000.
